What's happening in employment law

➤ Thursday 21 September

Our topical review of developments will examine recent and forthcoming changes in employment law. The courts are due to consider some important issues, including the meaning of "public interest" in whistleblowing cases and whether it is sex discrimination to pay at different rates for maternity leave and shared parental leave. Meanwhile, we're awaiting further news on previously announced plans for shared grandparental leave and caste discrimination. We will also take a look at the new Government's wider plans for the workplace, particularly in light of Matthew Taylor's review into modern employment practices. As usual, we will cover any significant new developments that arise closer to the event. Gender pay gap reporting update

➤ Wednesday 4 October

Now the first gender pay gap reporting "snapshot date" of 5th April 2017 has been and gone, all employers with 250 or more employees should be working on their statistics ready to publish by 4th April next year. The Government's reporting website is up and running, with the first few organisations having already published their information. With six months to go before the first reporting deadline, this session will provide a reminder of what employers need to do, consider how best to handle tricky issues and misleading statistics, and take a look at what we can learn from the numbers published so far.

What's happening in immigration law

➤ Friday 3 November

As ever, there is much to discuss in the world of immigration law - including significant changes to Tier 2, the introduction of the immigration skills charge and the abolition of some of the Tier 2 ICT categories. The Queen's speech has confirmed that new legislation will end free movement from the EU and make the status of EU nationals and family members subject to UK law. In the radically shifting landscape of business immigration, employers need to carefully consider business strategy and plan for potentially significantly increased costs. Join us for this session to examine these issues further.
